WHEREAS, in response to additional questions from the Provost surrounding the merger, the Faculty Senate developed an ad hoc committee to review and respond to the viability of such a merger and responded to the Provost on December 2, 2020 with hopes of implementation by the beginning of the spring 2021 semester; and

WHEREAS, the merger of these departments does not require any retrenchment of faculty positions; and

WHEREAS, the President recommends that the Board of Trustees approve the merger of the General Studies and Interdisciplinary Studies Departments, now known as Interdisciplinary Studies, effective for the spring 2021 semester;
