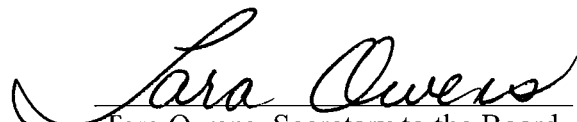

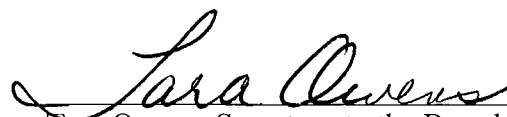

OPERATING BUDGET FOR THE 2021-22 ACADEMIC YEAR**

**WHEREAS**, budget allocations for the 2021-22 fiscal year align college resources with the goals and objectives of the College's strategic plan, *Lazer Focus 2016-21*; and

**WHEREAS**, the College administration has developed and presented a base institutional operating budget request of \$64,526,731 and proposed grant funding of \$14,000,000 for 2021-22;

**NOW, THEREFORE BE IT RESOLVED**, that subject to the approval of the County Legislature, a base institutional operating budget, including grant activity, for the 2021-22 fiscal year in the total amount of \$78,526,731 with a sponsor contribution of up to \$9,872,000 be adopted and submitted to the Board of Trustees of the State University of New York for approval.

**RESOLUTION TO APPOINT THE FIRM OF BONADIO & CO. AS THE COLLEGE'S INDEPENDENT AUDITOR**

**WHEREAS**, New York State Law, 8 NYCRR Part 602.1 (c) requires that community college records and accounts must be audited annually by an independent certified public accounting firm, and such requirement is reflected in Onondaga Community College Policy G1 "Appointment of Independent Auditors and Conduct of Independent Auditors;" and

**WHEREAS**, as a result of the Board of Trustees' directive, Onondaga Community College staff initiated a competitive bidding process and issued a request for proposals for audit services for the fiscal years ending August 31, 2021-2023, with the option to extend the contract for an additional two years; and

**WHEREAS**, proposals received were evaluated according to set criteria including, but not limited to a description of the audit process, evidence of good organizational and management practices, demonstrated experience and past performance, and pricing structure; and

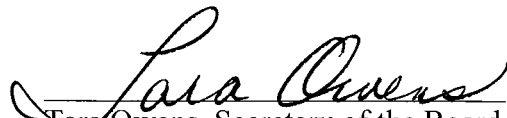

**RESOLUTION TO WAIVE 30-CREDIT LIMIT FOR  
AUTOMOTIVE TECHNOLOGY CERTIFICATE**

**WHEREAS**, the OCC Board of Trustees established a maximum credit requirement of 30 credits for certificate programs on June 1, 2010 in response to the College's widespread adoption of credit requirements significantly higher than limits recommended by the Middle States Commission on Higher Education; and

**WHEREAS**, OCC faculty develop degree and certificate programs in consultation with regional industry partners to meet workforce demands; and

**WHEREAS**, OCC is committed to developing and sustaining stackable credentials to enhance career pathways for middle-skilled workers; and

**WHEREAS**, a proposed 32-credit Automotive Technology certificate was recently approved by OCC's Faculty Senate; and


**WHEREAS**, OCC's Automotive Technology faculty consulted with Syracuse Auto Dealers Association, Independent Service Centers of New York, and Napa Service Centers in determining a course and credit sequence; and

**WHEREAS**, the proposed Automotive Technology curriculum was designed to help interested students transition seamlessly from the one-year certificate to the two-year A.A.S. program;

**NOW, THEREFORE BE IT RESOLVED**, that the OCC Board of Trustees approves the proposal to include 32 credits in an Automotive Technology Certificate program to be implemented in fall 2021.

FOLLOWING 2020-2021 ACADEMIC PROGRAM REVITALIZATION REVIEW**

**WHEREAS**, the Faculty Collective Bargaining Agreement outlines a process for Program Mix Administrative Review (6.18); and

**WHEREAS**, the Provost initiated the Program Mix Administrative Review, more commonly known as the Academic Program Revitalization Review, on November 12, 2020, selecting 10 programs for an impartial review based on significant and prolonged enrollment loss, current labor market conditions, analysis of projected regional employment opportunities, and curricular barriers to student success; and

**WHEREAS**, OCC's faculty undertook analysis of degree programs selected for review and were aided by the Faculty Senate in identifying relevant review criteria; and

**WHEREAS**, the discontinuance and deactivation of these programs requires no retrenchment of faculty, and teach-out plans have been developed to ensure that students currently enrolled in these programs are able to complete their degrees; and

**WHEREAS**, consistent with recommendations of the Provost and program faculty, the President recommends deactivation and future discontinuance of Alcohol and Substance Abuse Counseling A.A.S.; Apprentice Training: Electrical A.A.S.; Environmental Technology A.A.S.; Law Enforcement Certificate; Nuclear Technology A.A.S.; and Photography A.S.; and

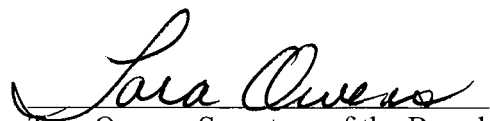

**WHEREAS**, the Honorary Associate of Arts Degree is the highest form of recognition offered by Onondaga Community College to persons of exceptional distinction; and

**WHEREAS**, the purpose of the honorary degree is to honor meritorious and outstanding service to the College, the State of New York, the United States, and/or to the community at large and to recognize persons whose lives serve as examples of the College's aspirations for its students; and

**WHEREAS**, Dr. Indu Gupta is the Commissioner of Health of Onondaga County. She completed her medical degree in India, her Master of Arts (MA) in Public Administration and Certificate of Advanced Study in Health Service Management and Policy from the Maxwell School at Syracuse University, and a Master of Public Health (MPH) from Johns Hopkins University. Dr. Gupta is board certified in Internal Medicine and is a Fellow of the American College of Physicians. Prior to her current role, she was an assistant clinical professor at University of California, Los Angeles (UCLA) after being in private practice for more than 15 years in Syracuse; and

**WHEREAS**, since the beginning of COVID-19 pandemic, Dr. Gupta has been leading efforts to protect the health of community residents by implementing strategies to test, track, isolate, and quarantine to control transmission of the virus in Onondaga County. She is leading a very successful COVID-19 mass vaccination campaign by the Onondaga County Health Department and working collaboratively with community leaders of faith-based organizations, educational institutions, hospitals, and local medical providers to ensure that there are no barriers to vaccination in Onondaga County. Her support of Onondaga Community College has been nothing short of exemplary; and

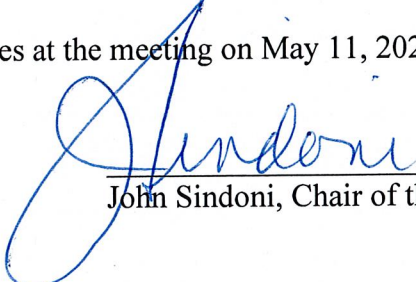

**RESOLUTION TO APPROVE THE USE OF BODY WORN CAMERAS  
FOR  
ONONDAGA COMMUNITY COLLEGE CAMPUS PEACE OFFICERS**

**WHEREAS**, in 2014, then President Barack Obama created “The President’s Task Force on 21<sup>st</sup> Century Police;” the mission of the task force was to examine how to foster strong, collaborative relationships between local law enforcement and the communities they protect. One of the recommendations was the use of body worn cameras, of which the ACLU and NAACP both supported with appropriate policies in place; and

**WHEREAS**, in December 2020, Campus Safety & Security Director Jeff Peckins was given permission to research the cost and feasibility of a body camera program at Onondaga Community College utilizing cost savings seen from a previous project within the department; and

**WHEREAS**, after research on the project was concluded, the proposal was then circulated through the shared governance process with review by Executive Council, Faculty Senate, and College Leadership Council; meetings were also conducted with representatives from CSEA regarding an implementation agreement with OCC Campus Peace Officers; and


**WHEREAS**, after positive feedback from the Faculty Senate and Executive Council, College Leadership Council voted unanimously on April 9, 2021 in favor of the program; CSEA has also responded and a memorandum of agreement has been executed to finalize implementation of body worn cameras; and

**WHEREAS**, OCC President Dr. Casey Crabill is recommending to the Board of Trustees that they approve the use of body worn cameras for OCC Campus Peace Officers in an effort to encourage transparency and accountability for the entire campus community;

**NOW, THEREFORE BE IT RESOLVED**, that the Onondaga Community College Board of Trustees approves use of body worn cameras for OCC Campus Peace Officers.
