WHEREAS, College Policies D4, D6, D8, I3, I4 and I11 are being updated and College Policies B21 and N8 are new policies; and


WHEREAS, the proposed College policy updates were presented to the Board at its June 25, 2024, meeting and have been recommended by the President;



ONONDAGA COMMUNITY COLLEGE FOR THE 2024-2025 ACADEMIC YEAR**


WHEREAS, the Onondaga Community College Board of Trustees has the authority to designate the official days of the Onondaga Community College Commencement ceremonies; and


WHEREAS, winners of the awards , which will be announced later this year, will be recognized at a ceremony this fall at the yearly NYCCT Conference;
