# **Executive Session**

#### One Team OCC

Dr. Crabill began her report with information regarding a new initiative on campus – One Team OCC. She provided introductions of Ryan Nellenback, Assistant Director, Student Onboarding, who is heading-up this effort on behalf of the college.

#### Strategic Plan

Dr. Crabill continued her report with an update on the Strategic Plan. She explained that the Strategic Plan is being assessed this year, and community input is crucial to its success. Next steps include a collaboration with FOCUS Greater Syracuse for testing in the broader community. The feedback we receive will help to sharpen the plan for the second half of our work. We hope to have a report at the June meeting on that feedback.

#### Title III

Dr. Crabill continued her report with an update on Title III. She introduced Wendy Tarby, Associate Vice President, Institutional Planning & Research, for more information. Ms. Tarby provided an overview of the grant logistics, including expenses to-date with reporting for the grant. She explained that they have signed contracts with Hobson's Starfish for predictive analytics and Inside Track for coaching. She then reviewed grant deliverable #1 – student

onboarding which was reviewed during the previous conversation with Mr. Nellenback. Grant deliverable #2 was discussed briefly by JT Ryan during the Education Committee meeting and consists of fully mapped programs including meta-majors. More information will be reported at the June board meeting.

# SUNY Updates/Legislative Priorities 2019-20/State Budget

Dr. Crabill continued her report with an update on SUNY. She explained that state budget deliberations continue, and we have been in touch with our representatives. The Assembly bill contained language for the funding floor, but it was not in the Senate or Governor's budget. We have been deep in conversations with SUNY ESF discussing programmatic opportunities between both colleges. Dr. Crabill explained that we were approached by their Interim President, Dr. David Amberg, about how we could work together. The conversations included sharing Athletic Directors and co-sporting events. ESF has a large capital project coming with renovations to their residence halls. Can we house those students for a few years while that work is completed? Additional meetings are taking place with faculty and curriculum alignment, particularly in the sciences. How can we help make ESF more visible to our students?

# OCC Foundation
