# **SUNY Updates**

Dr. Crabill reviewed the latest happenings at SUNY. She explained that work continues on SUNY Gen Ed, and the Interim Chancellor has scheduled regular meetings with the community college presidents. While the community colleges were pleased that the funding floor was approved, they were discouraged that they chose to do so at 2020-21 levels of funding. This will leave many of the colleges with gaps to fill. SUNY did receive extra state funding and the community colleges are hoping to leverage that funding to help close those gaps. TAP was extended to part-time students which should help a number of them. NYCCAP has a meeting scheduled for the end of June and Dr. Crabill will be taking Dr. Hilton to make introductions.
