Call to Order

At 9:05 a.m., Trustee Sindoni called the board meeting to order.

Swearing-in of Student Trustee Dawn Penson

Approval of the Consent Agenda

Trustee Sindoni requested a motion to approve the Consent Agenda. On motion by Trustee Alicea and seconded by Trustee Owens, the consent agenda was unanimously approved.

Chair's Report

Resolution of Appreciation to Barnes & Noble College Bookstore, LLC

Trustee Sindoni introduced Anne DeLand, Acting Director, Compliance & Auxiliary Services and John Cusick, Manager, Barnes & Noble College Bookstore, to provide an update on the Box of Books program. On motion by Trustee DeSiato and seconded by Trustee Alicea, the resolution of appreciation to Barnes & Noble College Bookstores, LLC, was unanimously approved.

Revised Board of Trustees Meeting Calendar
