OCC Foundation

Trustee Sindoni introduced Kathy D'Aprix, Director, OCC Foundation, to provide her report. Ms. D'Aprix began by stating that there are two current vacancies in the Foundation offices with the departure of Steffani Williams and Megan Detor. The Cruise and Views car show was a success, and we can expect the raffle for the Automotive Technologies truck to take place in 2024. Alumni Faces is scheduled for October 18, and we have a current appeal in place for former Alumni Faces recipients. Current gifts include donations from Key Bank, Wegmans, Syracuse Mets, and Micron. Ms. D'Aprix mentioned that scholarship demand is up, and we are

currently serving 557 students at \$490,645.50. Last year we spent \$569,216 for the entire academic year so demand is increasing. The Foundation is actively researching a capital campaign and consultant for the same and Ms. D'Aprix reminded Trustees of the Board of Trustees/OCC Foundation Board social event scheduled for November 9.

Student Success Challenge
